The following suggestions were made concerning the 1982-83 FFA AB-8 Budget:

- Support delegates attendance at State FFA Leadership Conference from inner city areas.
- Go to two issues on <a href="New Seed">New Seed</a> one to be out October 1 and one to be pre-convention.
- Determine mailing or distribution cost of <u>New Seed</u> and explore other alternatives.
- Regional supervisors check with Sections to determine correct number of copies to go to schools.
- Support some costs of delegate attendance to National FFA Convention.
- Budget the same total amount for Student Leadership Development but perhaps spend it differently.

#### ITEM 11 - OTHER AB-8 ITEMS

The Committee supports inservice activities for new FFA Advisors, both from AB-8 and Subpart 3 funding.

#### ITEM 15 - FFA CHAPTER OFFICERS CONFERENCES

The comments and suggestions made included the following:

- a. Sunday activities were questioned.
- b. A one-day activity was suggested.
- c. Regional officers are not sufficiently involved in this activity.
- d. Activity could be replaced by a better quality sectional level chapter officers' training program.
- e. Some advisors were involved to a higher degree in the sectional chapter officers' activity than they were in the regional activity.
- f. Sectional level chapter officers' training is more effective than regional level training.
- g. Did Tom Munter, or someone else, conduct an evaluation of the regional chapter officers' training activity? If so, the FFA Advisory Committee needs a copy of the report. If an evaluation was not made at the time of this activity, it should be done and the FFA Advisory Committee should receive a copy of the report.
- h. A discussion of the value of this activity should be held at section meetings and a response made to the FFA Advisory Committee and the State Staff.
- i. The program should be tailored to the needs of each region.

- j. A single format, done by State Officers, is more effective, better prepared, and more uniformly presented.
- k. December is too late for this activity.
- Set-up and food in the Southern and Southwestern Region activities were not good.
- m. There was some disagreement over the advisability of conducting this activity at the same time as the Southern California Leadership Conference.

## ITEM 16 - FFA EXHIBIT BOOTH

A report was given on the FFA Exhibit Booth. The question was raised as to whether it was available for use at county and local fairs.

## ITEM 17 - FFA FOUNDATION ACTIVITIES

Ken Harris reported on State FFA Foundation activities. The advisability of having a solicitor on a percentage basis was discussed. There was no consensus on this.

## ITEM 18 - 1982 STATE FFA LEADERSHIP CONFERENCE

There was some concern over presenting State Farmer awards at the regional level, but the consensus was "to give it a try."

## ITEM 19 - 4-H CONTACTS AND RELATIONSHIPS

4-H contacts and relationships were reviewed briefly. No particular problems were mentioned.

## ITEM 20 - FAIRS AND EXPOSITIONS POLICY STATEMENT ON JR. LIVESTOCK SHOWS

This policy statement was reviewed. The consensus was that it was confusing, hard to read, and hard to understand.

## ITEM 21 - STATE FFA OFFICERS' TOUR

The tour was in progress during the week of December 14-18, 1981. A report will be made on it at the next meeting of the FFA Advisory Committee.

# ITEM 22 - NEXT MEETING OF THE FFA ADVISORY COMMITTEE
