The purposes of having the Star Administrator award are as follows:

- 1. Have them attend regional meetings and state convention
- 2. Recognize them for help and support
- 3. Increase public relations (image)
- 4. Increase knowledge of FFA on the part of the administrator
- 5. Encourage involvement

Luanne Blucker moved to have a recognition program for administrators in which the provisions would be made by this committee. Jim Orradre seconded it. Motion passed.

There will be three levels of recognition - local, region, and state. Local - all who meet state criteria. Region - all Gold local winners (top 3 finalists go to meeting). State - each region winner.

The process in which the Star Administrator is chosen is as follows:

- 1. Local chapter submits Part I of the application to the state office.
- 2. State office will score and determine rank (bronze, silver, gold) for local presentation.
- 3. All Gold local winners will submit Part II of the application to the state office.
- 4. State office scores and picks 3 regional finalists to attend regional meeting.
- 5. One of the three regional finalists is chosen winner by highest score.

- 6. Region winner will attend state conference and will compete with the six other winners
- 7. Winner chosen by top score on application.

To make things easier and more clear we chose the following as our definition for administrator:

Any school district employee whose job description requires that 65% of his/her time be devoted to tasks which require he/she hold a California Administrator credential.

The rules we propose are as follows:

- 1. Must fit administrator definition.
- 2. Must submit applications to state office by due date.
- 3. Must attend regional/state meetings if an appropriate winner.

NOTE: If circumstances prevent attendance, there must be another administrator from same school to receive award.

Janel and Jim were to talk to advisors, teachers, etc. and ask opinion of this recognition program. This must be sent along with application ideas to Mr. Munter by January 1, 1987. Mr. Munter and Luanne will work out problems and make up application form.
