Special Committee Report

Jenny Thomas reported on the outcome of the subcommittee on State Degree Criteria. All committee members received the subcommittee report and its corrections. White/Thomas moved/seconded to submit the proposal to next year's state convention to be voted on as a constitutional amendment. Nichols/Richards moved to amend the main motion by adding on to the end "And that this proposal be distributed to CATA at the summer Ag teachers' conference and copies of the proposal be mailed to chapters at least one month prior to the mid-winter State Executive Committee meeting and that both distributions seek a reply." Amendment passed 11 to 0. The main motion as amended passed by voice vote.

Chapter Charter Status

Mr. Munter reported on the chapter charter status. Longacre/ Oehlschaeger moved/seconded that we accept the chapter charter of San Bernardino-Pacific FFA. Motion passed by voice vote.

National Convention Delegates

The Executive Committee reopened the motion from the last State Executive Committee which was to donate funds to Modesto Junior College for the Ed Leal Scholarship. After discussion the original motion stands as made at the mid-winter State Executive Committee meeting.

Mr. Heuvel discussed that the guidelines established last year by the delegates are so stringent that some people who are qualified were denied the degree.

State Officer Candidates

Mr. Heuvel informed the committee that he has allowed 5 of the state officer candidates this year to run regardless of application and reference trouble.
