Call to order

The Winter Meeting of the California Association State Executive Committee was called to order by President Kevin Potter on February 24, 1993 at 1:00 P.M. at the State Farm Bureau Headquarters, 1601 Exposition Blvd., Sacramento.

Review of Minutes

National Issues

Travis Hagen discussed the upcoming Constitutional Amendments which will be presented at the 1993 National Convention in November. One amendment deals with the realignment of the four National Regions and the other amendment deals with changing a requirement for the American FFA Degree relative to length of secondary agriculture education instruction. *Boughner/Wilmeth* moved and seconded to "refer the constitutional Amendment regarding the American FFA Degree to the State Delegates at the upcoming conference." Motion **Passed**, voice vote.

Young/Reynolds moved and seconded to "refer the Constitutional Amendment regarding the realignment of national regions to the State Delegates at the upcoming conference." Motion **Passed**, voice vote.

Hagen/Martin moved and seconded to "recommend to the state delegates that they go on record as being opposed to the American Degree requirement amendment."

Discussion followed. Motin Passed, voice vote.

Hagen/Pettey moved and seconded to "recommend to the state delegates that they go on record in support of the National Boundary Amendment." Motion Passed, voice vote.

State FFA Degree

It was announced that this year there are 715 students who have been found eligible to recieve the State FFA Degree. *Hagen/Pettey* moved and seconded that "the 715 students who have been deemed eligible to receive the State FFA Degree by the appropriate review committee, be hereby elected to that degree." Proposed State Program of Work

The following proposed changes to the State Program of Work were discussed.

- 1. Division I, Objective 2d; delete
- 2. Anywhere in the Program of Work where "Star Agribusinessperson" is referred to; change to "Star in Agribusiness"
- 3. Division II, Objective 3c; change to read "Invite state representative from the student organizations with which we have a current working relationship to attend and participate in California's annual State FFA Leadership Conference."

Boughner/Murray moved and seconded to "refer these proposed changes to the State Program of Work Committee at State Conference." Motion **Passed**, voice vote.

Chapter Status

Mr. Munter informed the committee that there are three new charter applicants and two reinstatement applicants eligible to be affiliated into the association.

Reynolds/Pettey moved and seconded to "accept the charter applications from Modesto-Johansen, Central Valley, and Alpaugh; and to accept reinstatement applications from Ventura and Cloverdale." Motion Passed, voice vote.

Proposed State Constitutional Amendments

The following are the proposed Constitutional Amendments that were presented to the committee.

- The Assistant State FFA Advisor shall be empowered to editorially change all references in the State FFA Constitution and Bylaws about practical experience to read, "Supervised Occupational Experience."
- 2. The Assistant State FFA Advisor shall be empowered to editorially change every reference to "vocational agriculture" in the State FFA Constitution and Bylaws to read, "Agricultural Education."

Hagen/Young moved and seconded that "the State Executive Committee place these items on the ballot at the 1993 State Leadership Conference." Motion Passed, voice vote.

Pettey/Murray moved and seconded that "the State Executive Committee recommend a "Do Pass" to the Delegates on both proposals for the 1993 State Leadership Conference." Discussion followed. Motion Passed, voice vote.

Proposal to Require Media Portfolio

There was discussion about requiring a media portfolio to accompany the State Star Reporter Application. *Boughner/Reynolds* moved and seconded to "refer this proposal to the Awards Committee at the 1993 State Leadership Conference." Motion **Passed**, voice vote.

Telephone Program Income Proposal

Jed Murray discussed the Telephone Program Income Proposal. The benefits from this program would be invested into the California Scholarship Program and State FFA Operations if passed. *Murray/Rossi* moved and seconded that "all income to the California FFA Association generated from the Members' Long Distance Telephone Advantage shall be allocated 50% to the California FFA Scholarship Program and 50% to State FFA Operations." Discussion followed. Motion **Passed**, voice vote.

Terra/Nicewonger moved and seconded to "approve the corrected minutes as mailed of the 1992 State Leadership Conference." Motion **Passed**, voice vote.

Honorary State Degree

California FFA Integrated Leadership Development Proposal
