AIG: Hugh

- Everything in the document can be created by a single AET report (hopefully)
- Need to make sure that the department of finance is ok with it good place to start
- We don't know how everything is going to be weighted and we don't know what they would get in those areas until they apply for the grant.
- Revision number of hours was removed it is now the number of activities
- Goal to have something to give to everyone at our summer conference in June so we
 have something to give to the department to get approved
- Next Step: Revise documentation to show what we need to look at when doing program reviews – good for our retreat
- AIG no language in the law that says anything about high school or middle school. If we get the 10.4 million, do we want to use that money to also include middle school?
 - Need someone else to look through it can't find the language about it being only 9-12 and not middle school

Calendar for the Following Year:

- Need to start looking at calendars so we can start planning for the next year
- Dane has dates from Mosaic for the next 7 years end of June
- That would mean we would have a convention site and no longer have a rotation
- Do we have the conversation or do we stick with a mid March convention.
- We have the option for next year if we wanted to move the convention to the end of the June in 2022
- Anaheim has a letter of intent for March 2023
- Suggestion keep it in March we have no clue what fairs will be going on. Following year, still go to Anaheim starting 2024 where do we want have our permanent location.
- Too much for teachers to handle right now if we decide to move it all to June.
- Fair conflicts in June Summer CATA is already an issue with San Diego section/teachers and we might find the same issues with the FFA programs.
- If you have dates to add to the calendar forward those so we can keep an updated calendar.

CDE Policies:

- Committee is creating an "anti-cheating" guide.
- Anything else you come up with the next few weeks make sure you send the
 information to Dane so they can add that to the guide.
- It's more than "guidance" it's going to be more of what to go over with your students, what is cheating and the consequences of cheating.
- Procotor might be apart of that as well
- Question: When they cheat who is determining that? State Staff will enforce. Just want to make sure that we are the correct on who is responsible. IF CATA oversees curricular code then would CATA be in charge?
- If someone has been caught cheating in the past, then the individual and team would be kicked out by the State FFA Advisor.
- Suggestion Easy access for teachers to say that they understand the cheating guidelines before they register for their contests.
- Hard to see if students are cheating virtually. We need to stress to the teachers about cheating and what is not acceptable. Send out a message to your region telling them to have those conversations. That message needs to come out now rather than later.

- Advisory Committee wanted "something" to hold people accountable and a better understanding about what happens when you cheat.
 - Additional measures having them be on Zoom and have to share on their phones of their surrounding areas (example of what they did with David).
- Update on Registration
 - Sites that are hosting their events, they need to submit all their information so
 Kerry and Susan can get all the information
 - Open March 1 and closes on April 1
 - o Issue small minimal fee for judging card to facilitate the registration
 - Waiting to hear back from hosts on Feb. 26th
 - When registering my team do we identify who is on the team with a drop down or just my team?
 - o Is it possible for teachers to identify students a month a head of time?
 - If we have judging card write the student information on the judging card it's a
 \$1 per student. If we change that name, it's additional funding.
 - Question purchasing scanners to run the cards (\$4,500 to scan cards)- with multiple sites, it might not be possible.
 - It is going to be up to the host site on what they want to do (using Judging Card scorecards or something else)
 - Hosts have until Feb. 26th on what they are changing on the contest.
 - Motion: Names must be entered at state finals registration
