# California Association FFA State Executive Meeting Meeting Minutes

A meeting of the State FFA Executive Committee commenced at 10:15am on Monday, February 18<sup>th</sup>, 2002, in the Conference Room at the California Farm Bureau Office, in Sacramento, California. Present were Jacob Wenger; State FFA President, Molly Fagundes; State FFA Vice President, Becky Roland; State FFA Secretary, Jeff Alves; State FFA Treasurer, Luke Browning; State FFA Reporter, Gabe Ponce; State FFA Sentinel, Meggie Fagundes; Central Region FFA President, Howard Wilson; North Coast Region FFA President, Martina Otterbeck; San Joaquin FFA President, Erica Flores, South Coast Region FFA President, Dennis Blackman; Southern Region FFA President, Bryan Dodson; Superior Region FFA President, Tim Hammerich; Past State FFA President, Bob Heuvel; State FFA Advisor and Charles Parker; Assistant State FFA Advisor.

Following the opening ceremonies, Jacob welcomed all in attendance and gave a brief overview of the agenda.

Becky Roland moved to approve the September 25<sup>th</sup>, 2001 meeting minutes. The motion was seconded and passed by voice vote.

**Membership Update** 

Molly Fagundes gave a brief overview of this year's membership information. Everyone received a handout that included the top ten largest chapters and smallest chapters and the number of members in each individual Chapter.

**National Convention Report** 

Becky Roland gave a review of the Delegate process and highlights of the National Convention, which was held in Louisville, Kentucky, October 24<sup>th</sup>-27<sup>th</sup>. Suggestions that were made for next year are as follows; the tours, which included Churchill Downs, Louisville Slugger and lunch at Joe's Crab Shack, were a great learning experience. The Caucus Meetings were very beneficial and gave the delegates the chance to ask questions so they were more prepared in discussion and committee work. In the future, it was recommended that California arrange the room assignments, and put members from different regions in each room. By doing this, it can give the California Delegation a chance to get to know more people from our state. It was also recommended that we continue the delegate training in Sacramento.

**Chapter Visits** 

Gabe Ponce gave a report on what the officer team did during chapter visits this past year. Three lesson plans were presented to over one hundred schools and they focused on Opportunities in the FFA, Careers in Agriculture, and Leadership. Suggestions were to make sure the evaluation forms were sent to Mr. Parker, so in future planning the Officer team can meet the needs of the students. Also, the State Conference Video was very beneficial.

**Chapter Officer Leadership Conferences** 

Gabe Ponce continued with a report of the COLC's. The State Officers presented a theme presentation and workshops on The Power of Influence, Goal Setting and Conflict Management and an overall workshop on the Agriculture Industry.

**Made For Excellence Conferences** 

Jeff Alves shared with the group information on MFE's. It was recommended that each Regional President review with their officer team any feedback they have received from the conference. Also, if possible, look into having more two-day conferences instead of one-day conferences. Students seem to get more motivated and excited at two-day conferences.

**Advanced Leadership Academy** 

Luke Browning asked for any suggestions that were made for the Advanced Leadership Academy Conferences. It was recommended that the current lesson plan be altered to also fit the more advanced students that have already had experience with using power point and writing resumes.

Everyone received a 3 by 5 card and participated in a mixer. After the activity we continued with the State Officer Reports.

**Foundation Meeting Report** 

Jacob Wenger handed out a list of sponsors for the State Judging Finals, the State Proficiency Awards and FFA Leadership Awards. A report on the FFA Center information will be provided by Rosemary Vernon later after lunch.

**State Judging Contest** 

Molly Fagundes handed out results of the State Finals in the areas of National Resources, Citrus, Tree Pruning and Vine Pruning. The Natural Resources Contest was held in Reedley, the Citrus, Tree and Vine Pruning Contest were held at Fresno State.

### New Horizons/California Insert

Luke Browning gave a brief oral report on the California Insert. Currently the California Insert cost \$7,000 to produce each issue and will be cut from 16 pages to 8 because of the lack of entries for articles and chapter scoops. Recommendations were to have an internship program, in partnership with Mr. Beard at Cal Poly, who will write articles for the California insert. Regional Officers should make announcements at Spring Regional meetings to remind chapters to send in articles for the Chapter Scoop and facilitate the Section officers in communicating with the Chapter Reporters, one-on-one. More suggestions were to have a generic form, included in each issue, which chapters can fill out and send back. The form would include areas for Chapters to fill in their latest events, community involvement, honors/awards, etc. Forms could be reviewed (by an intern) and written in paragraph form.

**Board of Directors Meeting Report** 

Jeff Alves gave a report on the past Board of Directors meeting that was held in Fresno. The announcement was made for all Regional Presidents to remind the Regional Supervisors that the Regional Budgets are Due April 1<sup>st</sup>.

Discussion followed for ideas of how we can express our patriotism and help or recognize the victims of September 11<sup>th</sup>. Meggie Fagundes moved that the State Constitution and Bylaws Committee discuss making one day of FFA week a Patriotic Day. The motion was seconded, discussion followed. Motion passed, voice vote. An outline/objective will be made to help the committee with it's recommendations.

**FFA Center Report** 

Mrs. Rosemary Vernon gave a report on the FFA Center. Regional Presidents are to announce the details of the contest designed to help find California FFA Alumni at the Spring Regional Meetings. She showed us the model of the Center and answered questions.

**State FFA Advisor Report** 

Mr. Heuvel gave a brief report on the latest information of the Budget Cuts proposed by the Governor. He explained the situation and how we will be represented on the Task Force Committee to ensure that funding will still be available. Mr. Heuvel also reported that California would receive a State Laison this year from the National FFA. This will help with our contact at the National level. He briefed us on the lapel pin issue that should be brought up somewhere at National Convention this coming year.

Meggie Fagundes, Central Region President, passed out her Newsletter and disused upcoming events.

Howard Wilson, North Coast Region President, gave a brief presentation of past events and passed out a flyer.

Dennis Blackman, Southern Region President, handed out a newsletter and reported on upcoming events and reviewed the slate for next year's officer team.

Erica Flores, South Coast Region President, passed out a pamphlet and reported on the South Coast's latest events and upcoming activities.
