Committee reviewed and made suggestions regarding the 2002 State FFA Leadership Conference. The following are the recommendations and/or comments:

- Look into utilizing display boards rather than flyers for the Officer Candidates.
- Add additional lines for voting booths.
- Do not dismiss participants for workshops/tours until sessions are completed.
- Allow delegates to utilize proxy's.
- Have a reception for Honorary Degree and Distinguished Service recipients.
- Have title of Proficiency Award as winners are introduced on Stage.
- Allow for tour tickets to be ordered with registration materials.
- Need to have better gender representation on Nominating Committee.
- Evaluate methods to reduce number of state officer candidates actually being interviewed.

Advanced Leadership Academy

Committee reviewed the ALA format. The following are the recommendations and/or comments:

- Public Speaking
- Ag Issues Forum

Committee is to poll their regions to see if there is interest in conducting Advanced Academies and what topics should be covered. Information gathered is to be returned to Mr. Parker prior to July 15.
