#### **National FFA Convention**

Review of the trip was conducted with the following comments.

- 1. Try to room chapters not part of the organized trip on a different floor or make sure that they understand they must follow all California rules.
- 2. Forward to National FFA request for them to work with rental car agencies in Indianapolis to insure that there are adequate supplies of vans for use during National Convention.
- 3. Inquire to see if Indy promotional video is available for use at Section, Region, etc. meetings.

### **Speaking Finals**

Discussion occurred involving the state leadership events help prior to the State Leadership Conference. The following was reported:

- 1. Prepared Public Speaking Finals (2) will again be held on the conference stage.
- 2. Creed winner will present the Creed on Stage during one of the Sessions.
- 3. State winning Advanced Parli Pro team will be conduct a five minute demonstration on stage during one of the sessions.
- 4. Judges table be placed near the stage in the center to facilitate contestants ability to recognize judges locations.

#### FFA Membership Update

Preliminary enrollment numbers were presented. Accurate FFA numbers are not available at this time. However, local program enrollment numbers have been calculated. Projected FFA membership for 2004-2005 is 63,361. This is an increase of 4,047 from what was reported last year.

#### Advanced Leadership Academy

Review was conducted of the ALA's delivered in January/February, 2005.

Consensus was that the ALA was well received by the students, they enjoyed the curriculum and that it was at the appropriate age level. One suggestion would be to rotate the topic (ie: Ag Literacy) with another hot topic so that those Junior who return as Seniors will not be bored.

#### Made for Excellence Conferences

Comments were made regarding the 2005 MFE's presented. Suggestions included:

- 1. Presenters should be dressed in business attire.
- 2. Activities and materials tended to be below age of those attending.
- 3. Look into writing own curriculum rather than using the National format.

#### **Greenhand Conferences**

Committee members shared their experiences regarding the Fall Greenhand Conferences. Comments included:

- 1. Teachers need to deal with other teachers showing up without being registered.
- 2. Teachers need to deal with other teachers who continually show up late.
- 3. Concern still exists regarding 10, 11, and even 12<sup>th</sup> grade students attending.
