- · How are sites selected?
- Should teacher educators select or recommend school sites?
- Should regional supervisors be the only ones to recommend school sites?
- How do you change it?
 - Extensive communication among the universities, regional supervisors, and state staff must continue.

- Given the complexities of student teaching placements, the overlapping conflicts, universities proximities, it is important to make a positive placement for the student teacher.
- Educators must work extensively with state staff, regional supervisors to assure that the school sites are approved by Regional Supervisor.
- Refer to the brochure developed by Master Teacher Conclave, headed by Richard Rogers approximately 10 years ago for criteria.
- Only regional supervisor approved sites will be used for student teachers, even if that site attends the Student Teacher/Master Teacher Conclave.
