- Contracts issues with getting contracts approved. Contracts meant to hire expertise that we do not have in CDE. But they were rejected because contractors were to hire other presenters.

XVI. CATA Executive Director Report - Aschwanden

- SB 1070 signed partnership academy funding, includes some CTSO
- SB 1458 signed API rank no more than 60% should test scores. 40% must be other measurements, but issues deciding what should be included.
- Weighted Student Formula (WSF) Governor's proposal to do away with all categoricals and use that funding to districts if they have 50% or more "Free/Reduced Lunch" and English Learners (EL). 7 seven year phase out, first year will be 5%, the 10%, then 15% increments.
- Obama proposing \$1 billion for partnership academies. California share would be \$130 million. Agriculture would be a good fit.
- Diesel engine survey. Region supervisors need to follow up. Portable diesel. 25 hp or more. (not Ag truck, stationary engines) Need by Jan. 20.
