<p>CATA & FFA Executive Director Update (Aschwanden)</p>	<ul style="list-style-type: none"> • Transition to FFA Executive Director position has been interesting <p>Staffing</p> <ul style="list-style-type: none"> • Katie Otto will be transitioning full-time to FFA Foundation • Maria Maberto is the new Assistant Director of FFA Financial Services; also working part-time for Central Region Consortium • Jennifer Stockton will be handling State Conference registration • CA FFA will be getting \$212,000 this year from CDFA from license plate program <p>FFA Center Update</p> <ul style="list-style-type: none"> • display will be put in lobby that highlights the FFA story and ag industry • mortgage needs to be paid off (Foundation Board wants to have a gala event in Feb 2017 to celebrate 10th anniversary of Center and burn the mortgage) • fundraising event is being planned in Tulare for March <p>CATA Report</p> <ul style="list-style-type: none"> • SB 1070 will not be renewed in its current state, but there will be support for professional development and CTSO's moving forward • CTE Incentive Grant is a work in progress • teacher prep programs need to be changed dramatically and quickly to begin fixing our drastic teacher shortage
<p>CALPADS Course Code Cleanup (Mooney)</p>	<ul style="list-style-type: none"> • CDE Course Code Definitions by Sector & Pathways (handout distributed) – Perkins unit is using this info to make decisions on what courses fit into which pathways; Perkins staff has been telling districts that they don't have approved pathways if they include courses from multiple pathways on this sheet
<p>State FFA Degree – AET Record Book (Mayfield)</p>	<ul style="list-style-type: none"> • AET has put together a state degree application option for us. Once student enters data, they hit the "generate app" button. It will produce an Excel version of our state application. It will also give a version # and access code which the verifier can enter on www.theaet.com to verify the information
<p>National FFA Convention Review (Sheehan)</p>	<ul style="list-style-type: none"> • Zane discussed the details related to this year's trip. • 490 participants for convention; 216 participants for DC trip; 49 chapters • We have a 200 room block in Indianapolis for next 3 years
<p>State FFA Leadership Conference (Mayfield)</p>	<p>Format & Schedule</p> <ul style="list-style-type: none"> • No major changes in schedule except for Sunday's delegate process • Looking at giving delegates a bar code ID which they can scan in at the polling booths for attendance purposes • Candidate Meet & Greet event will still happen but Mayfield is going to shore up some of the language to clean up the activity <p>Housing</p> <ul style="list-style-type: none"> • Housing Bureau website will open on January 15, along with conference registration • 1,900 rooms have been blocked for us

	<p>Nominating Committee</p> <ul style="list-style-type: none"> • Rules of Service portion added to Nominating Committee application • Apps must be postmarked on or before February 1 • March 1 – State Officer Candidate Exams (given in both Galt & Bakersfield.... Mayfield & Sheehan will oversee) • March 7 – State Officer Screening (nom comm will show up at FFA Center) <p>Amendment Proposals</p> <ul style="list-style-type: none"> • Hugh moved “to recommend a DUE PASS” on amendment proposal # 2 (removing CATA Executive Director language from Board of Directors part of constitution and replacing with “State Representative”. Motion was seconded and passed by voice vote.
<p>Leadership Conference Update (Sheehan & Mayfield)</p>	<p>GLC</p> <ul style="list-style-type: none"> • 31 conferences this year + 2 in Nevada (3 new) • 276 schools; 5,554 participants • Schedule is very difficult for the facilitators (too many days missed from college) • Discussion occurred regarding moving conferences earlier in the fall (last 2 weeks August & first 2 weeks of September) • Investigate the feasibility of hiring an intern to help Sheehan with conference planning <p>MFE & ALA</p> <ul style="list-style-type: none"> • Huge growth; 8th conference has been added (Visalia) • Looking at talking to FFA Advisory Committee and recommending that a task force be formed to evaluate the conference structure and provide some other options for handling the increased growth
<p>Honorary State FFA Degree Nominations (Mayfield)</p>	<ul style="list-style-type: none"> • 2016 nominees were discussed
<p>Distinguished Service Citation Nominations (Mayfield)</p>	<ul style="list-style-type: none"> • 2016 nominees were discussed
<p>Wonder Valley Conference Report (Aschwanden)</p>	<ul style="list-style-type: none"> • Overview of conference • Evaluation results were distributed and discussed • Conference will be held again next year as long as there is Perkins funding
<p>Middle School FFA Program Update & Proposed Amendment (Mooney)</p>	<ul style="list-style-type: none"> • Hugh went through FFA Constitution and changed wording to remove references that would prevent middle school chapters • Addition – to add the Discovery FFA Degree information • Chuck Parker moved “to recommend a DUE PASS on the amendment.” The motion was seconded. Voice vote failed. Greg Beard moved “that state staff will be on record as being neutral on the topic. The motion was seconded by Jack. Motion passed by voice vote.

National FFA Programs Report (Ben Meyer)	<ul style="list-style-type: none"> • National FFA Convention – roll out will be changed so that teachers have info before summer (lots more details will be provided earlier on); convention website will be redone; registration date will be very clear; moving towards electronically badging for all participants for convention • Website issues – dial general number and then option “5” to get direct assistance • Agriscience – split into 3 divisions (1) grades of 7 & 8, (2) grades 9 & 10, (3) grades 11 & 12 • National Chapter Award – National Chapter Quality Standards Guide will be developed; categories will be changed (Growing Leaders, Building Communities, Strengthening Agriculture) • Teacher Roster – before adding new teachers, please do a name search and see if they have an existing student account. If so, click on bottom “maintain roles” to add the instructor role. Then, click on their member number and create a username and password for them. Please deactivate those teachers who leave a district so they don’t have access to that school info.

Approval of Minutes (McCabe)	Chuck Parker moved to approve the minutes as printed. Motion was seconded and passed by voice vote.
CDE Report (McCabe)	<ul style="list-style-type: none"> • Governor will release his budget tomorrow. <p>Dr. Tom Adams is our new Branch Deputy.</p> <ul style="list-style-type: none"> • Lots of openings in the department during the year; difficulty trying to find people to fill spots • Dept of General Services has negotiated a 40% indirect cost rate with the UC & CSU system for contracts. If we can’t find a way to work around that, we will have to move the contracts to the community college system

CATA & FFA Executive Director Report (Aschwanden)	<ul style="list-style-type: none"> • Introductions of FFA Center Staff • Space at center is limited; desperately need to look at building some breakout rooms for conference presenter training • Lobby will soon highlight FFA history & agriculture industry • SB 1070 – bill that produces \$50 million for community colleges and some comes to CDE for CTE; used for professional development and CTSO’s; sounds like SB 1070 won’t be renewed; Dept of Finance won’t confirm anything about state budget but did say that funding would be taken care of • Boswell funds (\$250,000 annually) is secured for another 2 years • CTE Incentive Grant – funding formula seems obscure based on what we are hearing from districts regarding the funds applied for and the funds received • Teacher shortage continues to be a huge issue

FFA Foundation Report (Otto)	<ul style="list-style-type: none"> • Foundation is gearing up for a busy second half of fiscal year • Becoming more aggressive about bringing in funds and moving forward • Goal is to burn the mortgage on the 10th anniversary of the opening of the FFA Center (February 2017) and start Phase 2 • Fundraiser in Tulare area during the week of March 14; goal is to meet with new people and try to raise \$75-100,000 at a luncheon
