CALIFORNIA ASSOCIATION FFA STATE EXECUTIVE COMMITTEE MINUTES

The meeting of the State FFA Executive Committee and State FFA Advisory Committee was called to order by Luke O'Leary, State President, at 9:05 a.m. on September 25, 2017 in the Jerry T. Davis Board Room at the California FFA Center in Galt.

Welcome

A welcome was given by Luke O'Leary, State President. Luke provided greetings and welcomed everyone to the joint meeting of the State FFA Executive Committee, FFA Advisory Committee, and State FFA Adult Board of Directors.

State Advisor Update

Josiah Mayfield, Assistant State FFA Advisor provided an update on the open Superior region position, along with a report summary on student engagement for the 2016-17 school year.

CATA Update

Jim Aschwanden, CATA Executive Director provided an update on a variety of events and issues. Including:

- Record attendance and membership numbers for CATA Summer Conference and enrollment
- CATA has entered into a contract along with the "Get Real" coalition to develop a social media campaign to communicate the value of CTE

FFA Advisory Welcome

Mrs. Rosemary Cummings, State FFA Advisory Committee Chair provided greetings on behalf of the advisory committee. Mrs. Cummings then asked the FFA advisory committee members to introduce themselves.

State FFA Adult Board of Directors

Mrs. Mattes, State FFA Adult Board of Directors Chair provided greetings on behalf of the advisory committee. Mrs. Mattes then asked the Adult Board Members to introduce themselves.

State FFA Officer Report

The State Officers presented the report recapping the activities that the State FFA Officers have participated in to date.

The six regional presidents brought greetings from their region and summarized the activities and news within the region.

Hunter Andrade, State Reporter, distributed a listing of the due dates for submitting articles for possible inclusion in the California FFA New Horizon insert.

National Convention Trip

Bobby Marchy, State Sentinel, provided a schedule and information about the National FFA convention, and then shared an update on the growth of the association's trip.

State Conference Update

Josiah Mayfield, Assistant FFA Advisor provided a brief update on the State FFA Leadership conference.

Items discussed included:

Genevieve Regli, State FFA Secretary presented the chapter visit rotation. The item was discussed by the advisory committee.

Leadership Conferences

Josiah Mayfield, Assistant State FFA Advisor presented a conference update for GLC, MFE, ALA, and SLE.

- 1. **GLC, MFE, and ALA Curriculum**: Curriculum is going through a revision, and a senior conference will begin development this year.
- 2. **ALA Schedule:** 2018 is the last year we will conduct 8 ALA conferences in January/February. In the summer of 2018 California FFA will conduct up to 2 conferences in the summer (dates TBD) and 6 conferences in January/February.

Calaged Website & AET

The AET summary for 2016 was distributed. A few of the highlights of the report include

- Community Service: CA FFA members journaled 214,245 hours of community service in 2016
- SAE Economic Impact: CA FFA members generated nearly \$32 million dollars in total value

Recommendations: Teachers would like the year in Ag column to be added to the online roster view

Recommendation: Teachers would like to be able to generate a report on their student pathway numbers

Star Advisor Award

Discussion took place regarding who is interviewed for the Star adult awards. Genevieve Regli, State FFA Secretary moved and it was seconded to change the interview requirements to be "a student representative and an applicant, or adult representative of the chapter" **Motion passed by voice vote.**

State Executive Committee Expense Claim

Armando Nevarez, State Treasurer, gave each attendee a copy of the Expense Form and went over the claim voucher which must be completed by each Regional President. These forms should be submitted to the Assistant State FFA Advisor within two weeks of the meeting.
