Teach Ag Ed – Bonnie

- Shared a pathways document with the universities last week
- Created a document that helps students know what the steps are in to becoming an agriculture instructor
- In the past, if people came to Bonnie saying they want to be an ag teacher, she would connect them with someone
- The pathway document that was created has a few concerns:
 - Every institution is different really need to finesse it
 - Hoping the document will help them in the process and make it seamless for the students that are interested
 - Bonnie is looking for feedback is this valuable and if, so how do you see that looking.
- Is a document that has lots of information on it be a good idea? Is it worth our time?
- Discussion:
 - o Lots of variables feel it would be too much information on one document

- Worried that teachers and students will not look at it
- Could this be used as a companion piece with a career lesson, a video, a website – making it more useful and easy for a teacher to use in their classroom
- Create a lesson frame so teachers can utilize it in a lesson and using the existing pieces (like the TeachAg videos)
- Who is the audience? High School Students or "other" coming from out of state/industry. Flow chart that Grant Ermis has put together, Matt sends out weekly to people. Is this document going to be for High School or "other"
 - It is for both HS Student / "other"
 - Grant's information is very detailed
 - Technically, it should be one all inclusive document
 - If it is a document for both groups it needs to be high level.
- o Worried that it might be too much information for a HS student
- Feedback that was given from the universities had discrepancies of GPA, hours, etc.
- If this is a marketing document it needs to hook them.
- Need to go back to the committee we're not a "one size fits all".
- Texas marketing approach know about the institutions and then have the human connection go from there in a poster format (they have 11 colleges).

National FFA Update – Ben Meyer

- National FFA Convention want to host an in-person convention, but not too sure it will be able to happen. Hoping to have an answer before school ends (early May).
 - Hopefully to make an announcement of hybrid, smaller convention, virtual, etc.
- CDE/LDE made a list of what they would look like. Every single one will be in a hybrid/virtual method. It is possible that the early rounds might have students go to in person convention – but might be necessary. Not committed to it yet – but it might be coming.
- Not allowing late certified teams this year.
- American Degrees June 15th deadline (will get either approval or denial)
 - Please make sure that student's contact information is correct and current (old school emails, etc – were issues that they saw last year
- Proficiencies and STARs will be all virtual
- State Officer Summit hoping to have an in person with 2 officers instead of the full 6
- Please send the 3rd page information out to your teachers
 - Please make sure Agriscience winners are in the right category before submitting them
 - National Chapter Award they can qualify this year by providing 9 activities instead of 15. Still fill out the normal form and still accepting virtual.
 - Grants and money for chapters
 - o Zoetis Industry Support Program it's been open for awhile, due April 30th.
 - Harbor Freight for Teaching Excellence \$100,000 \$50,000 in prize money!
