

Agriculture Incentive Grant – State-Approved Professional Development Activities List

Requirement to be Eligible for Funding:

- Part A Funding: Every teacher (with at least 50%+ teaching assignment in agriculture) must participate in 6 state-approved PD activities per year.
- Part B Funding: Every teacher (with at least 50%+ teaching assignment in agriculture) must participate in 8 state-approved PD activities per year.
- For teachers with less than 50% teaching assignment in agriculture, please check with the Regional Supervisor for requirements.
