For the 2022 National Convention, California will stay at the **Hilton Indianapolis Hotel & Suites and the Sheraton Indianapolis City Centre Hotel, these neighboring hotels are both centrally located in Downtown Indianapolis.** Both the Hilton Indianapolis and Sheraton are walking distance to the Convention Center, Gainbridge Fieldhouse and food establishments.

The benefits of the state trip include access to the best hotels in the city in advance of National FFA's open registration, discounted costs through the State Block, and the Association takes care of the majority of the planning for you. State Staff coordinates reservations, books your travel and can leverage resources to ensure a stress-free trip.

TRIP OPTIONS & PACKAGES:

Wednesday, October 26 to Sunday, October 30, 2022

Regular Convention

Leave Wednesday morning from your preferred airport and arrive in Indianapolis that evening, with time to rest and prepare for Convention the next day. This trip is a good option for most chapters, even American Degree recipients. Leaves Indianapolis Sunday morning and returns home that afternoon/evening.

Monday, October 24 to Sunday, October 30, 2022

Early Convention

Leave Monday morning from your preferred airport and arrive in Indianapolis that evening, two days prior to Convention's start. This trip is required for Voting Delegates, but is also a good option for chapters that wish to arrive early for National CDEs, proficiencies or other award areas. Leaves Convention Sunday morning and returns home that afternoon/evening.

Adult/ Guest - \$1,630.00

Sunday, October 23 to Sunday, October 30, 2022

Early Convention

Leave Sunday morning from your preferred airport and arrive in Indianapolis that evening, three days prior to Convention's start. This trip is for chapters that wish to arrive even earlier for CDEs, proficiencies or other award areas, or educational tours. Leaves Convention Sunday morning and returns home that afternoon/evening.

Airline Transportation

Convention Registration

- Advisors will be responsible for registering their chapter for the Convention and Expo online at www.ffa.org. Payment will need to be sent directly to National FFA for convention registration fees.
- National Convention materials will be organized in advance of your arrival by State Staff and handed out with your California FFA registration materials during the arrival orientation meeting.
- California FFA will offer support with convention registration and troubleshooting.

TRIP REGISTRATION

National Convention registration can be found on www.calaged.org. All forms referred to in this document shall be accessed online. There are limited number of seats available for each trip and airport option, which will be sold in the order of registration submission.

Student Information

The Federal Transportation Security Administration (TSA) requires specific information to secure a ticket. The following information must be submitted using the California FFA website (www.calaged.org):

- Full Legal Name (First, Middle, Last - as it appears on ID)
- Date of Birth (mm/dd/yyyy)
- Gender (male or female)

Chapter Worksheet

The FFA chapter will complete an online worksheet that provides the following information:

- Transportation Needs
- Required Rooming List (organizing students by gender and rooming needs, especially if rooming numbers are uneven and you need to split a room with another school).

CANCELLATIONS OR NAME/TRIP CHANGES

Name changes can be made in writing by contacting the FFA Center and ***must be for the same gender***. There is no charge prior to August 1, 2022. After August 1, 2022 a \$100 name change fee will apply; a \$200 fee will apply after October 1, 2022.

All chapters who submit a registration online are financially responsible for the entire trip. There are **NO CANCELLATIONS**.

ONLY OFFICIAL FFA CHAPTERS MAY REGISTER

Registrations must be submitted by the local chapter advisor through the www.ffa.org website. Individuals may not make reservations directly with the California FFA Center. Registrations and payments are made and held only in the name of the FFA chapter, not in the name of specific individuals. Individual accounts and balances are maintained by the local chapter.

- Chapter advisors will read and agree to the terms and conditions liability and supervision for all trip participants during registration.
- Local school districts and designated advisors/chaperones are responsible for the oversight and management of themselves and their students. Local management includes securing proper insurance and medical waivers as designated by a chapter's local school board.

ADDITIONAL INFORMATION

CONVENTION REGISTRATION - NATIONAL FFA

Advisors will be required to register their chapters for the Convention and Expo separately online at www.ffa.org and will abide by National FFA's policies for registration and payment.

National Convention materials will be organized in advance of your arrival by California FFA staff and handed out with your California FFA registration materials during the arrival orientation meeting.

FLIGHT SUPERVISION

Each flight associated with the California FFA state-coordinated National FFA Convention trip will have a designated "Flight Leader" who will provide support to teachers whom are supervising the students on that particular flight from their home airport until they arrive at the Indianapolis International Airport (IND). Each Flight Leader will have a flight roster for each trip and connection. Flight Leaders will address questions, concerns and handle emergency situations, assisting the local advisor. Supervision and liability remains with the local teacher. **Official FFA Dress must be worn by members during travel.**

FLIGHT CANCELLATIONS

Airline companies will provide accommodations, including food, lodging and alternative travel connections, for customers in the event of mechanical error.

In the event of inclement weather, California FFA will provide up to two nights lodging and will provide alternative travel options. Travel plans will be at the discretion of California FFA. Meals will not be provided by California FFA.

DELEGATES ONLY

All delegate participants of the National FFA Convention must sign the California FFA Code of Ethics and Rules of Conduct for FFA Members form available at time of application and abide by the rules within it. Specific rules include a curfew, courteous behavior, respectful towards others property and authority, and a zero tolerance policy for the use of drugs, alcohol or other illegal behavior. Failure to abide by the rules may result in the student being sent home at personal expense.

Supervision of the California FFA Delegates in Indianapolis will be provided for by Agricultural Education State Staff personnel within the California Department of Education.

All California FFA delegates must participate in the California FFA coordinated Monday trip option. If a chapter registers a student under a different package who is later selected as a delegate, they will be allowed to switch without an additional service fee.

LODGING

All prices quoted for rooms within trip packages reflect the following lodging arrangements. Any special needs requiring alternative lodging arrangements will be accommodated only if space permits and will be done at additional cost to the participant (see Special Accommodations).

All students will have lodging arrangements in a double queen room designed for quadruple occupancy. There will be four students of the same gender assigned to each room; two students will share each queen bed. Students will be matched to rooms based on the rooming preferences in the chapter worksheet (available at www.calaged.org). The chapter worksheet will be required for the Department of Education to assign rooms. Uneven groups will be split in pairs before singles, if possible (e.g. in a group of five, a three and two split will likely occur over a four and one split). If there are uneven numbers of males or females, the Advisor will designate on the form which students are to be roomed with another school. All adults and guests will have lodging arrangements in a

double queen or single king occupancy (depending on the relationship of the individuals). There will be two adults to each room.

SPECIAL ACCOMMODATIONS

Any special accommodations made for passengers that deviate from the package (e.g. request of own room, travel arrangements out of a different airport, etc.) will be at the cost of the individual. Requests will be handled on a case-by-case basis; not all accommodations will be met.

Requests for special accommodations, either specialized travel or own room/family-assigned rooms must be in writing (email) and submitted by the registration closing deadline of Friday, July 15, 2022.

California FFA is not able to provide special accommodation for travel, in most circumstances, due to the volume of participants on the trip and limited airline resources.

The Association will attempt to provide assistance to any team that is representing the Association on a State level (a national CDE team, a STAR finalist) that has special requirements for that program that one of the preexisting trips cannot meet. Examples for this could include a student flying from a different airport out of state for college. Accommodations would be made for that specific team or individual, not the entire chapter.

SUPERVISION - MEMBERS

Supervision of the members of chapters within the California Association while at the National FFA Convention, unless otherwise noted in this document, are the sole responsibility of the local chapter. Neither California FFA, nor the California Department of Education accept any liability for supervision. All students must be supervised by an adult chaperone or teacher of agriculture as required by the local district. If the chaperone is not an employee of the local school district, the chapter must submit a letter from the School Principal or District Superintendent formally stating the school district's permission for the named adult to provide supervision for each specific student. Letters of supervision can be sent to the FFA Center, PO Box 460, Galt, CA 95632. All rules will be strictly enforced.

OFFICIAL UNIFORM

The official uniform of the National FFA Organization shall be worn by members at all formal events during the National FFA Convention. The National FFA Handbook lists specific requirements of "Official Dress" and the uniform.

Official FFA Dress must be worn by members during travel, per rules and guidelines in the Handbook of the National FFA Organization. Members will not be allowed to board their flight if not in uniform. Wearing the official uniform during travel provides the opportunity for students to engage with the public in agricultural advocacy and promote the organization, establishes a level of respect and appropriate behavior for members and assists staff with identification. The California Association adopted a bylaw that states "California FFA members should abide by National FFA uniform Guidelines when competing or participating in National FFA events". Members are expected to wear black nylons during the National FFA Convention.
